Your application is not complete unless it includes all of the following:

ACTIVE DUTY - AGR - NATIONAL GUARD - RESERVE APPLICANTS

If you are Active Duty, AGR, National Guard or Reserve please submit the following documents:

1. Driver's License
2. Military Orders (current assignment - Active Duty and AGR Only)
3. Military Service DD 214 / NGB22 (National Guard and Reserve Only)

(If our Director of Fraternal Membership does not receive these documents your application will not move on to Phase II of the Application Process)

RETIREE - VETERAN APPLICANTS

If you are a Retiree or Veteran that has an Honorable Discharge please submit the following documents:

1. Driver's License
2. Military Service DD 214 / NGB22 or Military Discharge Certificate

(If our Director of Fraternal Membership does not receive these documents your application will not move on to Phase II of the Application Process)



FRATERNITY APPLICATION PROCESS

During **Phase I** the Director of Fraternal Membership will process your application upon receipt of your \$65 application fee. You must also complete your NCSI background check in order to be moved on to **Phase II**. Upon completion of your background check you will receive a notification via email from our Director of Fraternal Membership either moving you to **Phase II** of the process or if you were found not qualified you will be notified via email thanking you for considering Kappa Lambda Chi and your \$65 **Non-Refundable** contribution.

During Phase II you will be required to complete the following:

1. You will be required to pay a \$375 **Non-Refundable** Intake Process Fee **PRIOR** to the Intake Fee deadline. The Intake Fee deadline will **ALWAYS** be due on or before the 1st day of Month prior to Intake start date.
2. Once we are in receipt of your \$375 **Non-Refundable** Intake Process Fee you will receive a letter via e-mail from our Director of Fraternal Membership moving you into Phase III were you will be assigned to a Local Membership Coordinator or Regional Membership Coordinator.

There will be NO exceptions!



NON-HAZING POLICY

Hazing includes but is not limited to the following activities:

- Requiring calisthenics such as sit-ups, push-ups, runs or any form of physically abusive exercise
- Forcing or requiring consumption of alcoholic beverages or any drug
- Requiring the ingestion of any undesirable or unwanted substance (i.e. spoiled food, insects, raw eggs, etc.)
- Partial or total nudity at any time
- Paddle swats
- Pushing, shoving, or intimidating candidates
- Assigning "pranks" such as stealing, painting objects, panty raids and harassing another organization
- Calling associates by degrading names.
- Activities which allow candidates less than six continuous hours of sleep
- Required road trips or kidnapping of candidates
- Yelling, screaming or use of obscenities at candidates
- Burning, branding or tattooing any part of the body, whether voluntarily or involuntarily
- Activities which call for confinement, jumping from heights and other potentially dangerous activities
- Activities which encourage failure to comply with the laws of local, state or federal government

Candidates going through the Intake Process agree **NOT** to participate in and/or report **ALL** Act(s) of Hazing to the Membership Coordinator **IMMEDIATELY**. Any Candidates or Members who knowingly participates in or facilitates any Act(s) of Hazing will be suspended or permanently expelled from Kappa Lambda Chi Military Fraternity Inc.
